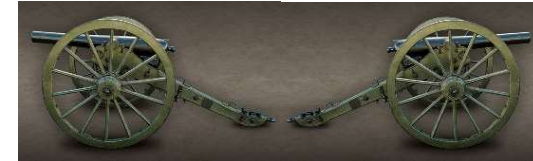

Uniform and Equipage

Hurt's Battery:

In order of importance in case the recruit is to acquire them over time.
The recruit has 18 months to fully outfit himself.

Shell jacket: Cadet or Richmond gray with solid red collar and cuffs, either CSA buttons or "A" artillery buttons

Trousers: Sky blue kersey wool (federal issue trousers)

Kepi: early war style with red band and dark blue crown, brass crossed cannons; period slouch hats also acceptable

Shirt: any shirt appropriate to the period

Footgear: either brogans or period boots

Canteen: any period canteen

Suspenders: period style

Belt: (Optional) black belt with CSA buckle

Firearms: (Optional): any correct sidearm and/or carbine

(Any member of the battery will be happy to assist with advice on uniforms, equipage and sources for same.)
